

**BCS INTERNATIONAL, INC.
PRODUCT LIMITED WARRANTY
TERMS AND CONDITIONS**

Warranty Policy: The BCS Limited Warranty is made to the original purchaser only and is non-transferable.

Limited Warranty: This Limited Warranty is limited to defects in materials and workmanship of the product as supplied by the manufacturer. BCS warrants that for the Warranty Period, under normal use, the Product is free from defects and workmanship. If the Product fails to meet this warranty of and Buyer gives BCS written notice thereof or returns the Product to the seller of the Product during the applicable warranty period, BCS shall repair or replace the Product, in its sole discretion. Buyer shall be solely responsible for the selection, use, efficiency, and suitability of the Product and BCS shall have no liability therefore.

Warranty Period: The warranty period begins on the date of purchase. BCS offers a ninety (90) day part/Product replacement warranty unless otherwise stated on the Product packaging. If your Product packaging states Limited Lifetime Warranty, BCS will warrant the original Product as long as you own the vehicle on which the part was originally installed.

Replacement Part(s)/Products: Replacement parts provided as warranty replacement carry the remainder of the original warranty term or 90 days whichever is longer.

Refunds: BCS reserves the right to refund the purchase price instead of replacing or repairing a Product.

Commercial Use: The warranty period for parts installed or for use on commercial vehicles expires 90 days from the date of original purchase, regardless of what may be printed on your Product packaging.

What is not covered: This warranty does not cover Products that fail as a result of improper installation, misuse, abuse or the failure of another part. Products used in connection with or installed for use on off road vehicles, racing or competition use have no warranty. Products modified for use or installed for use other than their original design and application have no warranty.) The warranty does not apply if the Product has been subject to modification, has not been installed or operated in accordance with the instructions or directions contained on the packaging of the product or was otherwise subject to abuse.

DEVIATIONS FROM THESE WARRANTY CONDITIONS SHALL ONLY BE MADE IN WRITING BY AN AUTHORIZED BCS REPRESENTATIVE. NO PERSON, INCLUDING ANY AGENT, DISTRIBUTOR, OR REPRESENTATIVE OF BCS, IS AUTHORIZED TO MAKE ANY REPRESENTATION OR WARRANTY ON BEHALF OF BCS CONCERNING ANY PRODUCTS SOLD BY BCS, EXCEPT TO REFER BUYERS TO THIS WARRANTY

Limitation Of Liability. NOTWITHSTANDING ANYTHING TO THE CONTRARY, BCS SHALL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES INCLUDING LOST PROFITS ARISING OUT OF THE PERFORMANCE, DELAYED PERFORMANCE OR BREACH OF PERFORMANCE OF THIS ORDER REGARDLESS WHETHER SUCH LIABILITY BE CLAIMED IN CONTRACT, EQUITY, TORT OR OTHERWISE. BCS'S OBLIGATION IS LIMITED SOLELY TO REPAIRING OR REPLACING (AT ITS OPTION AND AS SET FORTH IN SECTION 3 and 4), AT ITS APPROVED REPAIR FACILITY, ANY PRODUCTS OR PARTS WHICH PROVE TO BCS'S SATISFACTION TO BE DEFECTIVE AS A RESULT OF DEFECTIVE MATERIALS OR WORKMANSHIP, IN ACCORDANCE WITH BCS'S STATED WARRANTY. IN NO EVENT SHALL BCS'S LIABILITY EXCEED THE TOTAL PURCHASE PRICE SET FORTH IN THIS ORDER.

This Limited Warranty does not cover miscellaneous expenses including labor costs for removal and installation of a defective part, materials, lost time or wages, towing, lift, dock or storage fees. Some states do not allow limitations on how long an implied warranty lasts, or exclusions or limitations of incidental or consequential damages, your rights may vary state to state.

Reservation of Rights. BCS reserves the right to make subsequent improvements and changes in design in its Products without imposing any obligation to make such
